net4com Trade & Consulting GmbH (herein below net4com) is the controller of personal data, responsible for the processing of personal data collected through the „Contact Form“ and „Make Your Inquiry Form“ on the website. net4com Trade & Consulting GmbH is a limited liability company registered in the Commercial Register with the Commercial Court Vienna under No 368034b, with seat and registered office at Altmannsdorfer Straße 76a/11/4/12a, Vienna 1120, represented by Thomas Eidelpes. Information Collection

net4com collects personal information that may be used to identify a person or organisation such as name, title, phone number, email address, or mailing address. For security, we do not collect or store credit card information for online purchases. Other financial details are stored on our secure internal system for accounting purposes which is only accessible by a limited number of authorised staff.

In general, a person can browse our websites without giving net4com any personal information. Additional activities may require a person or organisation to be registered. As part of the registration process, we ask for a creation of an account where we collect additional personal information. We use that information for several general purposes: to tell individuals or organisations about products and services if requested; to fulfil requests; to contact an individual if we need to obtain or provide additional information; to verify the accuracy of our accounting records; to contact an individual regarding customer satisfaction surveys.

Your personal data collected through the „Contact Form“ are: your name and e-mail address. These personal data are collected solely for the purpose a reply to your question addressed through the „Contact Form“ to net4com to be sent. The legal grounds for processing of your personal data is your explicit voluntary consent. You have the right to withdraw your consent for processing of your personal data at any time, where withdrawal of your consent shall not affect the lawfulness of the processing performed prior the moment of withdrawal.

The personal data collected through the „Make Your Inquiry Contact Form“ are: your first and last name, the name of the company you work for, the type of the company you work for, your e-mail address, telephone number, country, and part/ service/ product you are interested in. The purpose of the additional field is to be filled with information on the part/service/product you are interested in or other specific information on the delivery; this field is not intended to collect other personal information about you. The legal grounds for processing of your personal data is to take steps prior to entering into contract for supply of the part/service/product you are interested in.

How Information Collected is Used

When a request for a quotation/order/information is placed through our website, we use the clients' personal information to process and fulfil the request. We may send an email to confirm or update the client on the status of their order. We may also use the clients' personal information to respond to any of their customer service inquiries. In case you are not willing to provide your personal data, respectively you do not want your personal data to be collected and processed by net4com, then you will not be able to send your question/ inquiry about a product/ service/ information to net4com through the website Contact Form, respectively Make Your Inquiry Form; consequently net4com will not be able to reply to your question/ reply to your inquiry about a part/ service/ product.

Sharing Information with Third Parties

We may share personal information with our trusted third-party service providers to help us manage and operate our websites, such as processing orders, including issuance of invoices, performing statistical analysis, sending emails or postal mail and providing customer support. Although these partners may not be affiliated with us, they are required to maintain the confidentiality of information and are not authorised to discuss, disclose or make any use of personal information except as necessary to provide such services. We or our third-party service providers may disclose personal information if we or they reasonably believe that it's necessary to: (i) investigate any suspected breach of the Terms of Use or Terms of Trade made by or otherwise relating to an individual or organisation; (ii) comply with applicable federal, state or local laws, rules, regulations or orders; (iii) to protect or defend the rights, property and interests of net4com, net4com business partners, affiliates or its guests, or the interests of our third-party service providers; and (iv) under exigent circumstances, to protect the personal safety of users of the website or the public.

How long we keep your data

net4com will store your personal data for a period, necessary for the preparation and sending of request of your question, respectively sending a reply to your inquiry for supply of part/product/service. If a business deal is concluded for sale of product/ service, then net4com is entitled to store the personal data for 5 years after completion of the transaction for accounting purposes and in order to prove performance of the engagement in case of disputes.

Unsubscribing or Changing Your Information

We want to communicate with individuals or organisations only if they want to hear from us. Individuals or organisations have the right to request confirmation of what information we hold about them and to correct, update or change such information. If they would prefer not to receive information from us or would like to correct, update or change personal information or preferences, they are asked to follow the instructions below. It is noted that objecting to our holding and using information may prevent us from providing some products or services. Requests to be removed from our communications might take up to three (3) business days to become effective (regular mailing lists may take up to 1 week). Individuals or organisations may receive emails or regular mail that is already in process even though they may have been removed. Even if removed from a list, if an order is placed online, we will send an email to confirm the order and may need to contact the client by phone, email or regular mail if we have questions about their order.

Information Security Measures

We use the latest encryption technology (Secure Sockets Layer or SSL) to secure personal information. The personal information provided is encrypted (or coded) using a secure server for maximum security. This coding makes it extremely difficult for anyone to reach personal information as it moves through our system.

What Are Your Rights?

Under the GDPR (General Data Protection Regulation), you have the right to access the information that we hold about you, to request the rectification and erasure of personal data or to restrict their processing and to object to the processing.
